And providing supports to the base of the pillar with a Cement Concrete 1:1-1/2:3 (One Cement, One and a half crushed stone sand and Three hard broken stone jelly) using 20 mm gauge hard broken granite stone jelly for all RCC items of works excluding cost of reinforcement grill and fabricating charges centering and shuttering but including Super Plasticiser, laying, vibrating with mechanical vibrators, finishing, Curing and shall be finished smooth with Cement Mortar 1:3 (One Cement and Three Sand) and applying 2 coats exterior paint to the concrete supports. (Including Erection Cost of Crane and other Machineries).	Erection of 20 Feet Height Traditional White Stone Pillar (Single Stone) by dismantling the existing fabricated pillar and concrete block and positioning the approved White Stone Pillar using suitable crane, including providing necessary base support with Cement Concrete 1:1½:3 using 20 mm gauge hard broken granite stone jelly, including Super Plasticiser, laying, vibrating, finishing, curing and Cement Mortar 1:3 finish, with 2 coats of approved exterior paint to concrete supports, including erection cost of crane, machinery, labour and all incidental charges, complete as directed by the competent authority.
